

Survey Methodology



TargetSmart designed and administered this multimodal survey. Three hundred ninety-two interviews (210 weighted) were conducted online among panelists who were matched to the TargetSmart voter file, and 348 interviews (290 weighted) were conducted online using email and text solicits (133 email, 215 SMS) from the TargetSmart voter file. In total, the survey reached 740 adults (500 weighted), age 18 or older, who are registered to vote in Florida from January 31 to February 4, 2021.


Quotas were designed to reflect the demographic and geographic distribution of registered voters in Florida. The data were weighted by gender, age, race, party registration, TargetSmart Midterm General Election Turnout Score, TargetSmart High School Only Score, and region by media market to ensure an accurate reflection of the population.

The credibility interval (the theoretical margin of error for a blended-methodology poll that relies partially on telephone-based probability sampling, and partially on non-probability based online panel sampling) is +/- 4.4%. The margin of error for subgroups is larger and varies. Percentage totals may not add up precisely due to rounding.

Direction of Florida - Time Series




Q.5 And generally speaking, do you think that things in Florida are going in the right direction, or do you feel things have gotten pretty seriously off on the wrong track?

Direction of Florida by 3-1-3 Party ID



Top 5 Issues for the Governor and State Legislature




Q.6 What would you say is the biggest issue in Florida that you would like the governor and state legislature to focus on?





Amount Paid in State Taxes






Q.30 Do you think each of the following groups of people in Florida pay too little in state taxes, about the right amount in state taxes, or too much in state taxes?



% Total Support Revenue Proposals








Q.18 And do you support or oppose more construction of toll roads across undeveloped parts of Florida?

Use of FL Sales Tax Holidays





% Major State Government Role In An Issue
























Q.21 And do you think it would be a good thing or bad thing for every eligible resident of Florida to be automatically registered to vote unless they opt out?




Q.22 And do you think it would be a good thing or bad thing for Florida to make voting by mail more widely accessible?

Q.23 And do you think it would be a good thing or bad thing for Florida to make early voting more widely accessible?








Q.25 Switching gears a bit, do you support or oppose reducing Florida's prison population of non-violent offenders?
