Survey Methodology

TargetSmart designed and administered this multi-modal survey. The survey reached 949 adults (696 weighted), age 18 or older, who indicated they were registered to vote in North Carolina. The survey was conducted December 6-12, 2022 via live phones with trained operators, and online via a link from a SMS or invite from web panel.

The sample was randomly selected from TargetSmart's enhanced voter file. Forty-three percent of respondents were reached on telephones (48 percent weighted). Sixty-six percent of the respondents who took the survey via phone were reached on a wireless phone (76 percent weighted). Thirty-six percent were reached via SMS and took the survey online (33 percent weighted). Twenty-one percent were reached via web panel (19 percent weighted). Quotas were assigned to reflect the demographic distribution of registered voters in North Carolina. The data were weighted by gender, age, race on file, party registration, TargetSmart Midterm General Election Turnout Score, TargetSmart High School Only Score, and region by congressional district to ensure an accurate reflection of the population.

The credibility interval (the theoretical margin of error for a blended-methodology poll that relies partially on telephone-based probability sampling, and partially on non-probability based online panel sampling) is +/- 3.7%. The credibility interval for subgroups is larger and varies. Percentage totals may not add up precisely due to rounding.
